VOTING ELIGIBILITY REQUIREMENTS

Defined by the Constitution and Canons of the Episcopal Diocese of Texas

Section 2.2 Persons Eligible to Vote – Definitions of Confirmed Communicant and Communicant in Good Standing

Men and women at least 16 years of age, who are enrolled confirmed communicants in good standing of the Parish, are entitled to vote for members of the Vestry and upon all questions requiring the action of the Congregation, but none shall be admitted to serve as members of the Vestry except those who are at least 18 years of age. Voting may be by absentee ballot under such rules and regulations as may have been established at a prior Parish Meeting.

For the purpose of Title III.2.2, an enrolled communicant in good standing of a Parish is a communicant in good standing who is enrolled as such in the records of such Parish.

For purpose of the Canons, a confirmed communicant or confirmed communicant in good standing is a communicant or communicant in good standing who has been confirmed by a Bishop of the Episcopal Church or a Bishop of a Church in communion with the Episcopal Church or has been received into the Episcopal Church by a Bishop of the Episcopal Church.

For purpose of the Canons, a communicant in good standing is a communicant who for the previous year has been faithful in corporate worship, unless for good cause prevented, and has been faithful in working, praying, and giving for the spread of the Kingdom of God.

Rector's Report

Dear Trinity parishioners, friends, and family,



The year 2020 has marked us forever. There was so much sorrow as the pandemic spread throughout our country and took so many lives. We closed the church to the public in March 2020 on the instructions of the Diocese and have not re-opened fully since as the metrics for health and safety that were set up initially were never reached. We completely changed the way we did ministry and liturgy. We were able to pivot and continue to serve in every area of parish life. The analysis is ongoing as we continue to live into that reality. We are working on a fuller COVID learnings report some content will be in my Annual Parish Meeting Rector's report and subsequently published on our website.

We are planning on a steady roll towards open as I write. Without being trite I want to emphasize that Trinity pulled through for each other and the community, once again. I am proud to serve such an incredible community. The massive importance of our mission as an inclusive church committed to serving Christ in each other rang loud and clear during these extraordinarily difficult and de-humanizing days. I am proud to serve this community.

Our work with the Diocese to implement a program which has been instrumental for strategic visioning in other parishes around the Diocese and nation ground to a halt as we shifted course from the year we had planned. We will take that work up again when it makes sense to do so.

Happily, we were able to call a fulltime Curate, the Rev. Luz Cabrera Montes. A Curate in the Diocese of Texas is a recent seminary graduate and newly ordained transitional deacon who begins work in the summer before their ordination to the priesthood in January. They are placed for two years in this case summer 2020- summer 2022. The Rev. Montes will be ordained a priest on February 20, 2021. She has been a joy and pleasure to work with even in these trying times.

I want to thank our dedicated staff, both stipendiary and non-stipendiary: The Rev. Canon Henry L. Atkins, Jr., The Rev. Luz Cabrera Montes, Collin Boothby, Fabian Berrios, April Sloane Hubert, Pelayo Parlade, Ken Jones, Pat Laubach, Larry Laubach, Carol Turley, Carolyn Reyes, Sam Jones, Booker Lakes, James Candler, Rosa Gutierrez, Terri Fielder, Laura Benavides, Erica Zavala, Yolanda Catalan and Kelly Mercer. All have remained healthy and safe in their service to God.

I am so grateful to all the members and officers of the vestry! God bless each one for their commitment.

Senior Warden's Report

In my January 2020 report, I spoke of the vestry's 2019 work to consolidate our Vision and Goals and of the strategic planning efforts that would follow. It is an understatement to say that 2020 did not turn out like we expected! We had barely entered the season of Lent when the pandemic caused the closure of schools and businesses and caused us to move services and other



activities online. Little did we know at the time that we would still be meeting virtually today.

We turned our attention to adjusting to this world of virtual services, Zoom meetings, and finding ways to continue our ministries effectively and safely. All of us have faced our own individual challenges during this time, too. Trinity adapted and persevered: we continually improved our online offerings; we continued to feed the hungry and homeless; we found ways to stay connected and care for one another and our community. We did it all with a small staff and some dedicated volunteers. Thanks to John Escoto and the Endowment Board, our building has been restored and beautified. Although our revenues decreased somewhat in 2020, many of you remained faithful in giving. We finally obtained FEMA grant money for work done after Hurricane Harvey thanks to the tireless efforts of Steve Lee and others. We were able to reduce some costs and we finished the year in a better place financially than we might have expected when the pandemic began. We ask your help in continuing to pledge and give so that 2021 can be even better.

Through it all, the Heart of Midtown has continued to beat strong!

We all look forward to the time that we can gather in person again. It is difficult to say when that will be. As I write this, we are seeing the highest rates of coronavirus cases and deaths since the beginning of the pandemic and the University of Washington IHME model currently projects nearly 170,000 more deaths by May 1. It is hard to grasp the scale of this tragedy. There is much hope, though, as vaccines become increasingly available. Those vaccines will save lives. Given the vast numbers of people who need to be vaccinated, it may take several months to get enough people vaccinated to truly return to some sense of normalcy. Masks and distancing will be part of our lives for some time to come. We will continue to track the numbers and information and make the best decisions that we can, considering Trinity's resources. I can assure you that our decisions are based in love for our community, because we want to keep you safe.

In 2021, we will return to the business of strategic planning for the future. We may not know what the next new normal will look like, but we know that Trinity is committed to living out its mission of Making God's presence real by sharing Christ's life-changing love.

Thank you all for your continued work to support Trinity's mission, for the gifts that you offer and for the love that you show to one another. It is truly a privilege to serve with you!

Junior Warden's Report

Before 2019 came to an end, the Trinity Exterior Restoration project was kicked off!!

The restoration compromised three items of work on church property -1) Cleaning/Repairing/Protecting of limestone, 2) Caulking and glazing of all windows (except stain glass), and 3) Gutter replacement at various location of the property. All limestone was treated with a special formulation that will minimize deterioration caused by weathering elements while strengthening the surfaces



and mortar joints. Exterior lights were repaired and replaced with the help of scaffolding.

- Abbot Garden: Limestone cleaned, windows caulked/glazed, and gutters replaced
- Administration: Limestone cleaned, windows caulked/glazed, and gutters replaced
- Bell Tower: Limestone cleaned, eight louvers painted, limestone spall repairs (100+), rework of four pinnacles, and reinstallation of lightening protection
- Bishop's Garden: Replace slabs of limestone, windows caulked/glazed, and gutters replaced/repaired
- Columbarium: Limestone cleaned and limestone spall repairs
- Holman Street: Limestone cleaned, windows caulked/glazed, gutters painted, entry way and three arches painted
- Northeast side (rear of property): Limestone cleaned, windows caulked/glazed, gutters replaced, and painted/repair roof eaves (atrium room kick-out)
- Sanctuary: Limestone cleaned

Western Specialty spent total seven months cleaning, repairing and protecting the limestone. Binswanger Glass caulked and glazed all windows and Vogler Sheetmetal replaced gutters all during this time. The attentiveness, the honesty, the craftmanship, and the respect to the church are key values that Western displayed everyday they spent on church property. The results speak for themselves! Western Specialty went above and beyond to complete the Trinity Exterior Restoration project under budget!

We closed out 2020 projects with the completion of the replacing all the ceiling tiles in Fellowship Hall as FEMA funds from Hurricane Harvey (2017) finally came in. Many thanks to Steve Lee who has taken on the responsibility as the church liaison to FEMA. His persistence has enabled the church to finally receive all funds for Hurricane Harvey projects already completed.

Special Thank You to the Jackie Rose and the Trinity Endowment for providing the necessary capital for the Trinity Exterior Restoration project in 2020 as well as approving remaining funds from the restoration to be used for important small projects that need attention.

Lastly, Thank You to James Candler for supporting the daily maintenance at the church and assisting the property committee with projects as needed.

The Property Committee meets every 2nd Tuesday of the month to plan and prioritize activities for the church properties (Historic Church, Bering House, and Rectory). The members include Ben Blanding, Bob Davenport, Bob Dorries, Dan Cooley, Eric Beam, Jim Luke, Larry Laubach, Nick Bilski, and Tim Lawson. Meetings are open to anyone who would like to know more information about what we do.

We shall sing again!

Well, it's over. For myself and so many others, 2020 was the most challenging year ever. When news broke of a superspreader event at a choir rehearsal in Skagit Valley, Washington, choirs worldwide stopped in their tracks. March 8, 2020



was the last Sunday the Trinity Choir sang in person for worship. But what a marvelous Sunday that was! The choir presented William Byrd's Mass for 4 voices and sang Compline that evening.

Since then, the members of the choir and I have enjoyed meeting weekly via Zoom. While we sometimes discuss music, most often our discussions revolve around our world, our faith, and our hopes for the future. While already a tight-knit ensemble, one silver lining has been learning more about each other. I am blessed to be the leader of such a wonderful group of people. The volunteers of the Trinity choir bravely took on new musical projects in the time since COVID, recording an anthem and 5 hymns for our online worship services. I am grateful for Pat Emerson, Vickie Varteressian, Catherine Reed, Amy Luke, Carol Turley, Phil Turley, John Merullo, Miguel Stonecipher, and Bill Jones, who have all contributed countless hours of song, thought, prayer, and recordings – and they even put up with my bad jokes!

Trinity received the PPP loan which allowed the staff singers to be paid through the end of their contracts for the 2019-2020 year. In the summer it was a pleasure to put together another Midday Music in Midtown concert series with them, this time all virtually. In the wake of George Floyd's death, these concerts featured music by African American and black European composers. Many works of these composers are not regularly performed in the canon of standard repertoire. Showcasing them helped move them out of obscurity and was another silver lining of the year.

Unfortunately, like so many other churches, Trinity suffered financially in 2020. At the start of the new program year in September, the staff singer budget was slashed about 80%. Errin Hatter, Andy Horton, Tony Sessions, and Harrison Moore – thank you for your faithful commitment to Trinity during this challenging time.

Eliza Nicholson, who started as a staff singer at Trinity in 2018, resigned during the summer after graduating with her master's degree from University of Houston. She has moved to Dickinson, TX where she is an assistant choir director at a high school. Sasha Mitchell, our choral scholar from Houston Community College, has transferred to Sam Houston State where she is pursuing a bachelor's degree in Music Education. They were both great assets to the Trinity music program during their time here.

One of Trinity's greatest strengths is its music program – on any given Sunday you can hear music composed by great women and men of the faith from the 3rd century to yesterday. Plainsong, jazz, choral anthems, hymns, spirituals, contemplative piano, roaring organ and more all joyfully resound in praise. Having such a program requires significant fiscal support and investment.

One of the reasons I am pledging in 2021 is to continue the church's song eternal at Trinity. If you are able, I would encourage you to do the same.

With millions of Americans already vaccinated and more doses on the way, there is a light at the end of this long, dark tunnel. With any luck, by the end of the year we will be able to gather in person once again and triumphantly sing out great hymns of the faith. Until then, I offer you a new verse to the spiritual "We Shall Overcome" to sing from your living room, kitchen, or wherever you stream the services.

Oh, deep in my heart, I do believe We shall sing again, someday.
